## 6.1 eServices Launch by Sonia Gauvin, Treasurer

eServices, a new online platform for water & sewer invoices, was launched today. eServices offer a paperless experience, with secure online payment options, email notifications and the ability to view past invoices.

### **Key Features & Benefits**

- Saves Time: No need to wait for invoices in the mail or visit City Hall.
- Convenient: Accessible 24/7 via phone, tablet, or computer.
- Instant Payments: Payments are applied instantly to your account.
- Paperless Experience: Clients who opt-in to eServices will be 100% paperless.
- Operational Cost Savings: Reduced operational costs due to the digital nature of the platform.

## **Non-Residential Accounts**

#### How to Sign Up

## 8. MUNICIPAL BY-LAWS

# 8.1 Proposed Municipal Plan and Zoning By-Law Amendments for Properties Located at 1270 to 1296 Daniel Drive and 1330 Vanier Boulevard

The Planning Department received a rezoning request for six parcels located at the intersection of Daniel Drive & Vanier Boulevard: lots bearing civic numbers 1270 to 1296 Daniel Drive and 1330 Vanier Boulevard and bearing PIDs 20027793, 20027785, 20027769, 20027744, 20349247 and 20348231.

For the purpose of the Zoning, the owner is requesting that the properties be rezoned from R2 (Single and two-unit dwellings) to ID (Integrated Development) to permit the development of a residential complex comprising several row-type multi-unit dwellings.

The rezoning would enable higher-density residential use in a growing area, aligning with municipal planning goals.

## 9. DRAFT RESOLUTIONS

## 9.1 Weight Restrictions - Spring 2025

Moved by Deputy Mayor M. Willett Seconded by Councillor J.-F. LeBlanc

**WHEREAS** the *Motor Vehicle Act* empowers a municipality to impose weight restrictions on highways under their jurisdiction; and

**WHEREAS** the Administration has reviewed a plan and makes recommendations for the designation of the 2025 weight restrictions.

**NOW THEREFORE BE IT RESOLVED** that Council designates the following weight restrictions, effective March 17, 2025, until further notice:

1. On all streets in the City of Bathurst except those exempted in Item 2, vehicles may operate with each axle weight not exceeding eighty percent (80%) of the maximum axle weight for which the particular vehicle may be operated in the Province of New Brunswick provided that each axle weight does not exceed that upon which the registered weight is based.

2. The following streets are exempt from these restrictions and are subject to the conditions below:

a) No spring weight restrictions:

All streets located within the Bathurst Industrial Park;

Route 134 - Miramichi Avenue from the junction of Route 11 to Bridge Street;

Route 134 – Bridge Street, from Miramichi Avenue to Murray Avenue;

Route 134 – Murray Avenue from Bridge Street to Main Street;

Route 134 - Main Street to St. Peter Avenue via Harbourview Blvd. North;

Route 134 - St. Peter Avenue to Main/King, via Harbourview South to Murray Avenue;

St. Peter Avenue to City limits, Beresford;

Route 180 – Vanier Boulevard from St. Peter Avenue to Route 11; Route 430 – King Avenue from the junction of Route 11 to Dumaresq Street, and Dumaresq Street from King Avenue to Murray Avenue; St. Anne Street – Route 11 to Evangeline Street; Route 315 – Sunset Drive from Vanier Boulevard to Brown's Bridge; Route 315 - Sunset from Civic address 2000 to city limits; Carron Drive – from Bridge Street to Sutherland Avenue.

In summary, the truck route through the city is now 100% of axle weight, without any tolerances over such weight.

b) Restricted to 90% of maximum licensed axle weight

Cape Road - Bridge Street from City Limits to Miramichi Avenue

3. Passenger buses and City of Bathurst vehicles be exempt from the above restrictions.

# 9.2 Application to Host the "Congrès mondial acadien" in 2029

**WHEREAS** an interprovincial candidacy committee made up of elected representatives of Restigouche RSC, Chaleur RSC, Bonaventure MRC and Avignon MRC, presented a letter of intent in July 2024 to the Société Nationale de l'Acadie indicating a common will to submit an application that the Baie-des-Chaleurs be host of the Congrès mondial acadien (CMA) in 2029; and

**WHEREAS** the nominating committee, in collaboration with professionals from the region and community partners, is currently working to develop a nomination package to be submitted to the Société Nationale de l'Acadie on March 14, 2025; and

**WHEREAS** the CMA is a unifying event of international importance that contributes to the vitality, unity and modernity of the Acadian people and generates major economic and tourism spinoffs for the host region; and

WHEREAS the event has never taken place on our territory; and

**WHEREAS** the support of partners in this domain and from the municipalities is necessary to complete the nomination package and that it establishes an important part of the evaluation; and

WHEREAS an important proportion of the population of our community is of Acadian origin;

**THEREFORE BE IT RESOLVED THAT** the municipality of Bathurst supports the interprovincial nomination of the Baie-des-Chaleurs as the host of the Congrès mondial acadien in 2029.
