## 9. DRAFT RESOLUTIONS

# 9.1 Supply of Coarse Highway Salt

**WHEREAS** for the 2024-2025 season, the City of Bathurst purchased its road salt from Nutrien in Sussex, NB at the price obtained by the Province of New Brunswick by taking advantage of their universal purchasing clause; and

WHEREAS this clause allows any municipality in the Province to obtain salt at the same rate as the provincial contract; and

WHEREAS the lower supply price came with a higher trucking cost, meaning the City of Bathurst must revisit supply and trucking costs annually regardless of the Provincial agreement. THEREFORE, BE IT RESOLVED THAT after reviewing the cost of trucking for the 2025-2026 season, members of council approve the extension of the contract to purchase an estimated quantity of 3,000 MT of road salt from Nutrien in Sussex, NB, for the total cost of \$201,660.00, plus tax.

## 9.4 Items Discussed In-Camera

# 9.4.1 Money in Lieu of Parkland

**Moved by** Councillor M. Skerry **Seconded by** Councillor R. Hondas

**WHEREAS** the applicant, René St-Pierre, submitted a Subdivision Plan to the City of Bathurst Development Officer for approval; and

WHEREAS the purpose of the subdivision plan is to create lot 2025-1 (PID 20018610); and

**WHEREAS** the Subdivision By-Law requires the setting aside of land for public purpose or, Council may require, in lieu of park land, that a sum of money be paid to the City; and

**WHEREAS** the City of Bathurst already owns several blocks of land designated as parkland in these areas and the size of land to be reserved as parkland for this subdivision will be too small for development.

**NOW THEREFORE BE IT RESOLVED** that money be paid to the City in lieu of parkland equivalent to 6% of the market value of the land, for a total of \$1,920. The amount received will be deposited in the Parkland Reserve Account, as discussed In-Camera on November 17, 2025, pursuant to section 68 of the *Local Governance Act*.

#### 9.4.2 Demolition of Dilapidated and Dangerous Buildings

## 9.4.2.1 East Bathurst, Former Coast Guard Building, PID 20761466

The Building Inspector presented a report indicating that the building, located at the former Coast Guard Building in East Bathurst (PID 20761466), constitutes a hazard to public safety due to its dilapidated and structurally unsound condition. The City Clerk called for the presence of the owner or any person holding an encumbrance on the property to provide evidence to the contrary. As no one came forward, the council proceeded with the matter.

**WHEREAS** the former Coast Guard Building in East Bathurst has been abandoned for several years; and

WHEREAS the building has been subject to vandalism, arson, and has deteriorated to the point of posing a public safety risk due to its dilapidated condition and compromised structural integrity; and

**WHEREAS** the property is in violation of the City of Bathurst Dangerous or Unsightly Premises By-law 2019-05; and

**WHEREAS** the property owner has not appealed the Notice to Comply issued on November 3, 2025; and

**WHEREAS** Council reviewed the Municipal By-Law Enforcement Officer's report during an In-Camera meeting held on November 17, 2025;

**BE IT RESOLVED THAT** Council authorize the Municipal By-Law Enforcement Officer to enforce the City of Bathurst Dangerous or Unsightly Premises By-law 2019-05 by proceeding with the demolition of the dilapidated building and the removal of any hazards to public safety from the former Coast Guard Building (PID 20761466) and that the Mayor and City Clerk be authorized to sign all related documents on behalf of the City of Bathurst.

## **9.4.2.2 2670** Route **180** South Tetagouche

The Building Inspector presented a report indicating that the building located at 2670 Route 180, South Tetagouche (PID 20761466), constitutes a hazard to public safety due to its dilapidated and structurally unsound condition. The City Clerk called for the presence of the owner or any person holding an encumbrance on the property to provide evidence to the contrary. As no one came forward, the council proceeded with the matter.

**WHEREAS** the property located at 2670 Route 180 South Tetagouche has become a hazard to the safety of the public by reason of being vacant or unoccupied and dilapidated; and

WHEREAS Roy Consultant Engineering Services has reported that the property is dangerous, and should be demolished, citing collapsing interior gypsum, severely damaged exterior decks, broken windows, forced-open doors, and widespread interior debris; and

**WHEREAS** the property is in violation of the City of Bathurst Dangerous or Unsightly Premises By-law 2019-05; and

**WHEREAS** the property owner has not appealed the Notice to Comply issued on November 3, 2025; and

**WHEREAS** Council reviewed the Municipal By-Law Enforcement Officer's report during an In-Camera meeting held on November 17, 2025;

**BE IT RESOLVED THAT** Council authorize the Municipal By-Law Enforcement Officer to enforce the City of Bathurst Dangerous or Unsightly Premises By-law 2019-05 by proceeding with the demolition of the dilapidated building and the removal of any hazards to public safety from 2670 Route 180, South Tetagouche (PID 20258109) and that the Mayor and City Clerk be authorized to sign all related documents on behalf of the City of Bathurst.
